Application and Fee must be received to hold spot by no later than Monday June 27th, 2019 (All Fees are nonrefundable) Vendors keep **100%** of their proceeds for the sales on the day of the event. No vendor will be permitted to erect signs or display products obstructing the view of other vendors, also it is prohibited to distribute promotional materials outside the limits of your booth.

Vendors are responsible for all Set up and Cleanup of their booth space, and their immediate surrounding area. Spaces are 10x10. Please bring proper walls to secure booth as well as weights (no stakes in the ground). There will be no power available. Some generators may be allowed with prior approval.

*Retail Vendors must also provide a copy of their City of Santa Paula Business license. Business licenses can be obtained at the cost to themselves of \$25/year and can be attained through the following site:

Food Truck/ Food Vendor application Acceptance Policy: Confirmation is based on the dates and times of application submissions AND Payment. We reserve the right to turn down applications (and return fees) based on number of applications received and overall variety of applications. All food trucks/ vendors must be able to operate independently of any resources at Downtown Santa Paula Including water, electrical, refrigeration and any materials. (spaces for food truck are susceptible to vehicle sizing, if applicable) Please acknowledge if need/ use of 3 bin sink, or if one will be brought by you. Deadline for Food Vendors is May 27th, 2019

Food Vendors must provide proof of insurance, food safety certificates, Copy of TFF permit from Ventura County Health Department, Fire extinguishers, and environmental pads to absorb any liquids, oils for containment and are prohibited from selling Alcohol products unless otherwise permitted.

All Vendors Load In/ Load Out: entering Downtown Santa Paula from the 8th Street entrance. Set up can begin at 8am, time of arrival we know varies for each product so we ask that everyone be set up and ready to go by 10am., Event staff will assist in direction to assigned space, please bring necessary help, cart, and dollies. There are no vehicles permitted on street after 10am. Please be courteous to City Staff/ Volunteers. Load out will start no earlier than designated event end time. Vendor parking will be in the public parking lots located on Davis Street and the alley North of Main St behind the buildings.
